### 1. GENERAL REGULATIONS

### 1.1. Purpose of CPEDP

The Core Professional Educational Program (CPEDP) of the Bachelor's Degree, implemented by FSBI HED «Altai State University» in the training direction- 41.03.05 International relations is a system of documents, developed and approved in the light of the requirements of the labour market, on the basis of the Federal State Standard for Higher Education, in the training direction- 41.03.05 International relations; approved by the order of the Ministry of Education and Science of the Russian Federation from «15» June 2017 № 555.

The educational program has a profile - «Actual Problems of Theory and Practice of International Relations», which characterizes its orientation to the areas of professional activity related to the current state of international relations at different levels, and determines its subject-thematic content, the prevailing types of educational activities of students and the requirements for the results of their development.

The Core Professional Educational Program regulates the objectives, expected results, content, conditions and technology of the educational process, evaluates the quality of the graduate's training in this area and includes: Curriculum, timetable, work programmes of disciplines (modules), practical programmes, evaluation tools, teaching materials.

The main goal of the educational program in the training direction- 41.03.05 International Relations, profile "Actual Problems of Theory and Practice of International Relations" in general is to obtain an education that allows the graduate to carry out research, expert-analytical and project work in the field of international relations, based on the universal, general professional and professional competencies formed in the course of training and the skills acquired for their implementation in practice in accordance with the requirements of the Federal State Educational Standard for Higher Education, contributing to its demand in the labor market.

Educational activities in this area of training are conducted in the State language of the Russian Federation.

The period of full-time education, including holidays, provided after the completion of the State Final Certification, regardless of the educational technology used, is four years.

The complexity of the development of the CPEDP by students in training direction- 41.03.05 International Relations, the profile "Actual Problems of Theory and Practice of International Relations" for the entire period of training in accordance with the Federal State Educational Standard of Higher Education is 240 credits and includes all types of contact and independent work of the student, practice, research and time allocated for quality control of the student's development of the CPEDP.

The educational programme is developed in the form of a set of documents which is updated annually taking into account the development of science, culture, economy, technology, social sphere and the needs of the labour market.

Admission to study is based on the results of entrance tests, the form and list of which are determined by the "Rules of admission to the FSBEI HED "Altai State University" for training in educational programs of higher education — bachelor's programmes, specialty programmes, master's programmes", approved annually.

### 3. CONTENT OF CPEDP

The content and organization of the educational process in the implementation of Bachelor's degree program 41.03.05 International Relations, training direction (profile) "Actual Problems of the Theory and Practice of International Relations" is regulated by the Academic program (curriculum) for the year of admission, the annual academic calendar, working programs of disciplines (modules), programs of practice, as well as the evaluation and methodological materials.

### 4.1. Academic Program (Curriculum)

Realization of educational activity at realization of CPEDP 41.03.05 International Relations, training direction "Actual Problems of the Theory and Practice of International Relations" is realized on the basis of the Academic Program 2020-2021, including in the compulsory part social-humanitarian, communicative-activity, general professional modules, and also the module "Physical Education and Health", and in the part formed by participants of educational relations - modules of business and profile modules defining a direction of the program.

The Academic Program specifies a list of modules, practices, certification tests of the state final certification of students, other types of learning activities (hereinafter together - types of learning activities), indicating their volume in credit units, sequence and distribution over periods of study. The Academic Program allocates the amount of work of students in interaction with the teacher (contact work of students with the teacher by type of classes) and independent work of students in academic hours. For each discipline (module) and practice indicated form of interim certification of students.

The Academic Program includes a compulsory part and a part formed by the participants of educational relations.

The Academic Program of the programme consists of the following units:

Unit 1 "Disciplines (modules)" includes disciplines (modules) belonging to the compulsory part of the programme and disciplines (modules) belonging to the part formed by the participants of educational relations.

The disciplines (modules) in philosophy, history (Russian History, General History), Foreign Language, and Life Safety are implemented within Unit 1 "Disciplines (modules)" of the program;

Unit 2 "Training Skills" includes educational and industrial practices related to the compulsory part of the program.

Unit 3 "State Final Attestation", which fully refers to the compulsory part of the program and ends with the qualification specified in the list of specialties and areas of higher education approved by the Ministry of Science and Higher Education of the Russian Federation. Unit 3 includes preparation for and passing the State Examination in a Foreign Language, preparation for and passing the State Interdisciplinary Examination and preparation and defense of the Graduation Qualification Thesis.

The volume of the compulsory part, not including the volume of the State Final Attestation is more than 50% of the total volume of the program.

If there is a contingent of persons with developmental delays and persons with disabilities, at their request, the opportunity to study according to an educational program adapted to the specifics of their psychophysical development, individual capabilities and, if necessary, ensuring the correction of developmental disorders and social adaptation of these persons.

The Academic Program is a component of the Educational Program (CPEDP), the electronic version is posted on the website in the section of compulsory information about the educational organization <a href="http://www.asu.ru/sveden/education/#plan">http://www.asu.ru/sveden/education/#plan</a>.

#### 4.2. Academic Calendar

The educational process of an educational program is divided into academic years (courses). In an academic year, a total duration of at least 7 weeks is set as a holiday. Upon the application of the student, he/she is granted a holiday after the State Final Attestation.

The calendar, which is approved annually, specifies the periods of study activities and vacation periods. The discipline (module) Course Plan includes:

volume of the discipline (module) in credit points with an indication of the number of academic or astronomical hours allocated to the classroom work of students with the teacher (by type of classes) and to the students' independent work;

content of the discipline (module), structured by topics (units) with an indication of the number of academic or astronomical hours and types of academic classes allocated to them;

list of educational-methodical support for students' independent work on the discipline (module);

fund of assessment tools for intermediate attestation of students on the discipline (module);

list of basic and additional educational literature, necessary for mastering the discipline (module);

list of resources of information and telecommunication network "Internet" (hereinafter - network "Internet"), necessary for mastering the discipline (module);

methodological guidelines for students to master the discipline (module);

list of information technologies used in the implementation of the educational process on the discipline (module), including a list of software and information reference systems (if necessary);

description of the material and technical base necessary to carry out the educational process for the discipline (module).

Evaluation Fund (EF) for the discipline (module), which is part of the Course Plan of discipline (module), is designed as an appendix to it, and includes: a list of competencies in the development of the educational program; description of indicators and criteria for evaluating competencies, the description of assessment scales; standard control tasks or other materials necessary to assess knowledge, abilities, skills and (or) experience; methodological materials that determine the assessment procedures of knowledge, abilities, skills and (or) experience of activity.

### 4.4. Training Skills Programs

The Training Skills Program includes:

indication of the type of training, method and form (forms) of its carrying out;

list of planned results of practical training, correlated with the planned results of educational program;

indication of the place of internship in the structure of educational program;

indication of internship volume in credit units and its duration in weeks or in academic hours;

the contents of the practical training;

indication of the forms of reporting on the practical training;

the fund evaluation for intermediate attestation of students on practicum;

list of educational literature and Internet resources necessary for carrying out the practical training;

list of information technologies used during carrying out of practical training, including list of software and information reference systems (if necessary);

description of material and technical base necessary for carrying out the practical training.

Evaluation Fund for midterm certification of students on practical training, which is a part of the Practical Skills Training program, is designed as an appendix to it, and includes:

the list of competences in the process of mastering the educational program; description of indicators and criteria of competence evaluation, description of evaluation scales;

typical control tasks or other materials necessary for evaluation of knowledge, abilities, skills and (or) activity experience;

methodological materials defining the evaluation procedures of knowledge, skills and (or) activity experience.

The Core Educational Program provides for the organisation and delivery of study and work placements.

<u>Types of educational practical trainings</u>: orientation and research work (gaining basic skills of research work).

<u>Types of practical trainings</u>: professional practical trainings, research training and research work (on the subject of the Graduation Qualification Thesis).

### 4.5. Final State Certification (FSC) Program

The Final State Certification (FSC) of graduates is compulsory and is carried out after the development of the basic educational program in its entirety. The program is approved at the meeting of the Department of General History and International Relations and brought to the attention of students no later than six months before the FSC.

The Final State Certification in the training direction -41.03.05 International Relations is carried out in order to determine the compliance of the results of the development of the Core Educational Program by students with the requirements of the Federal State Educational Standard for this training direction.

The Final State Certification includes preparation for and taking the Final State Examination in a Foreign Language, preparation for and taking the Final State Interdisciplinary Examination and performance and defense of the Graduation Qualification Thesis.

Taking the State Exam and defense of the Graduation Qualification Thesis is carried out in the terms established by the Academic Schedule of the educational process of the University.

## General Description of the Model of the Final State Examination in a Foreign Language

The Final State Examination in a Foreign Language is held in 2 stages. The first stage is a written examination. The second stage is an oral examination.

In the first stage, students are asked to:

- 1. Listen to an authentic monologic/dialogic text on general humanities or professional topics in a foreign language of up to 6-7 minutes duration (double presentation).
- 2. Demonstrate general and detailed understanding of the text by completing written assignments to choose the correct answer, fill in the blanks, complete sentences, answer questions, etc.

When listening to a text, the ability to extract the main information contained in the text as accurately and adequately as possible is assessed.

The written text is assessed for completeness and adequacy of content, the ability to convey the content of what is heard without semantic distortion, structural, stylistic, grammatical, communicative correctness of the written text.

### In the second stage, students complete oral assignments:

- 1. Summary of socio-political Russian-language text (5,500-6,000 characters) in a foreign language. Time for preparation 45 minutes.
- 2. Discussion with the teacher on problematic issues related to the topic covered. (3-4 questions) Without preparation.

When assessing oral speech, fluency, meaningfulness of the statement, the ability to choose linguistic means in accordance with the communication objectives, stylistic, grammatical and intonational correctness of the statement are taken into account.

When summarising a read text, the following is assessed: adequacy of content, absence of semantic distortion, ability to summarise the main points of the presented text, volume and correctness of extracted information, adequacy of implementation of communicative task of the Russian-language text in a foreign language.

# General Description of the Final State Interdisciplinary Examination Model for the Training Direction – 41.03.05 International Relations, "Actual Problems of International Relations"

The Final State Interdisciplinary Examination is conducted on the disciplines of the educational program, the results of mastering which are crucial for professional activity of graduates in such modules (disciplines) as General Professional Module ("History of International Relations and Diplomacy", "History of International Relations in the East", "Basics of International Security", "World Politics", "Modern International Relations", "Russia in Global Politics", "International Conflicts in the 21st Century. "), Module of International Political and Economic Analysis ("International Relations Theory"), International Regional Module ("Regional Aspects of International Relations", "Economic and Political Processes in the CIS"), International Legal Module (Customs Law), Project Module (Theory and Practice of Negotiation Process).

Form of the exam holding - examination cards. During the exam, graduates must demonstrate the ability to solve problems at the modern level of professional activity, professionally present information, scientifically argue and defend their point of view, based on the knowledge, skills and competencies acquired.

The examination cards include one theoretical question and one practice-oriented task.

## General Description of the Model of Performance and Defense of the Graduation Qualification Thesis

Graduation Qualification Thesis is the final undergraduate paper that completes a course of theoretical study for a major. The subject of research should be an independent problem, relevant in scientific and practical relations, from the field of history, theory and contemporary political, economic and legal international relations.

The information base of the work should include materials from all available sources in Russian and foreign languages relevant to the topic, including information on electronic media. To write the Graduation Qualification Thesis (GQT) it is necessary to use all available works of domestic and foreign authors, the totality of which would really reflect the degree of study of the problem.

GQT is a completed student's work, which demonstrates the level of readiness of the graduate for independent professional activities. The texts of the GQT are checked for the volume of textual borrowings.

A Graduation Qualification Thesis and the supervisor's review shall be submitted to the State Examination Commission no later than two calendar days prior to the defense. The defense of the GQT takes place at an open meeting of the state examination commission for the defense of GQTs in accordance with the established procedure.

Graduation Qualification Theses are defended publicly at the meetings of the State Examination Commission. The dates, time and place of the defense of GQTs are determined by the schedule of State Certification Examinations.

The Evaluation Fund for the Final State Certification includes:

the list of competencies that should be mastered by students as a result of completing the educational program;

description of indicators and criteria for assessing competencies, as well as assessment scales:

typical control tasks or other materials necessary to assess the results of mastering the educational program;

methodological materials determining the evaluation procedures of the results of the educational program.

### 4.6. Personal Development Course Plan

Personal development on the CPEDP of training direction – 41.03.05 International Relations is carried out continuously both during the educational process and in the extracurricular time by creating an educational environment as a set of professional, object-space, behavioral, event and information-cultural environment of students on the basis of the developed and approved "Personal Development Course Plan in the Federal State Budgetary Educational Institution of Higher Education "Altai State University" (Rector's order № \_\_\_ "\_\_" 202\_\_). (Rector's order № \_\_\_ "from "\_\_" \_\_\_ 202\_\_) (hereinafter referred to as Personal Development Course Plan).

The goal-oriented basis of educational activities in the realization of the CPEDP of 41.03.05 International Relations is to create conditions in the process of training that contribute to the development of social, professional and cultural competence of students, the development of personality, capable of independent life choices, respectful of the rights and freedoms of others, able to carry out constructive social interaction. When planning personal development of students in the realization of the CPEDP of training direction – 41.03.05 International Relations, the main principles are:

1. Personal development in the realization of the educational process is a part of the university environment, and its results are formulated in terms of universal and general

professional competencies of the FSES in the training direction of 41.03.05 International Relations.

The disciplines of the University core, which form universal competencies, involve active learning of roles (professional, social) on the basis of critical and systemic thinking, teamwork skills, communication competencies, understanding of the principles and methods of project activities, etc., are implemented within a single integrated system of education of students and socio-cultural development environment that meets the content, forms and methods of activities of the state policy on youth education and personal development.

The disciplines of the General-Professional Module "Political Science and Regional Studies" are aimed at:

- combination of professional competence with mastering the latest technologies and practical skills necessary to implement professional knowledge in the following spheres of professional activity: scientific research of international relations, administration of diplomatic, economic and other relations of RF government bodies with representatives of respective countries and regions of the world; organizational and communication activities to ensure diplomatic, foreign economic and other contacts with foreign countries and regions;
- formation of social and personal qualities necessary for effective professional activity;
- creation of optimal conditions for professional and personal development and self-realization, self-determination and self-improvement.
- 2. Personal development organized during extracurricular time is event-driven, varied and focused on voluntary self-determination and students' freedom of choice of activities proposed in the Personal Development Course Plan, which, in turn, provides:
- keeping the unity of the educational and upbringing space and the continuity of the stages of the educational system;
- achievement of social consolidation and harmony in the conditions of growing social, ethnic, religious and cultural diversity of our society on the basis of formation of Russian identity and commonality of all citizens and peoples of Russia;
- formation of a general activity base as a system of universal actions that determine the ability of a person to learn, cognize, and cooperate in learning and transforming the world around them.

"The Personal Development program in the Federal State Budgetary Educational Institution of Higher Education "Altai State University", including the schedule on personal development, is posted on the official website of the University in the section of mandatory information about the educational organization.

The plan of personal development and extracurricular work of the Institute of History and International Relations for the academic year is an integral part of the University Academic program and is approved by order of the Rector as an Appendix to this general university plan, posted on the website of the Institute of General History and International Relations.

## 5. CONDITIONS FOR THE IMPLEMENTATION OF EDUCATIONAL ACTIVITIES UNDER CPEDP

### 5.1. Educational and Methodological Support of CPEDP

Educational and methodological support of CPEDP of training direction - 41.03.05 International relations, profile «Actual Problems of Theory and Practice of International Relations" is fully contained in the documents governing the content and organization of the educational process.

The content of the documents provides the necessary level and scope of education, including independent work of students, as well as provide for quality control of students' mastering of the basic educational program as a whole and its individual components.

### 5.2. Logistics and Information Support of CPEDP

Resource support for the educational programme of training direction - 41.03.05

International relations, the profile "Actual Problems of the Theory and Practice of International Relations" is formed on the basis of the requirements for the conditions of the educational program, determined by the FSES in the training direction, taking into account the current regulatory framework, taking into account the features associated with the level and profile of CPEDP.

The University has the right to property and other legal grounds for the material and technical support of educational activities (premises and equipment) for the implementation of the Bachelor's degree program in Unit 1 "Disciplines (modules)" and Unit 3 "Final State Certification" in accordance with the academic program.

The rooms are auditoriums for classes under the Bachelor's degree program, equipped with equipment and technical means of education, the composition of which is determined in the study programs of disciplines (modules).

The rooms for students' independent work are equipped with computers with the option of connecting to the Internet and are provided with access to the Electronic Information and Educational Environment of the University.

The rooms for foreign language classes are equipped with language laboratory systems (audio, video and multimedia).

The University is provided with the necessary set of licensed and freely distributable software, including domestic production (the set is determined in the study programs of disciplines (modules) and is updated as necessary).

The library fund is made up of printed publications at the rate of at least 0.25 copies of each of the publications specified in the study programs of disciplines (modules), practices, for one student from the number of persons simultaneously mastering the relevant discipline (module), undergoing the appropriate practice.

Students are provided with access (remote access), including in the case of e-learning, distance learning technologies, to modern professional databases and information reference systems, the set of which is determined in the study programs of disciplines (modules) and updated (if necessary).

Each student is provided with individual unlimited access to the Electronic Information and Educational Environment of the University, as well as outside of it, during the entire period of study.

The Electronic Informational and Educational Environment of the University provides:

access to academic program, discipline course plans, training skills programs, electronic educational publications and electronic educational resources specified in the discipline course plans, training skills programs;

formation of an electronic portfolio of the student, including the keeping of his works and grades for these works;

recording the progress of the educational process, the results of interim certification and the results of the Bachelor's program;

academic classes, evaluation procedures of the results of education, the implementation of which is provided with the use of e-learning, distance learning technologies;

interaction between participants in the educational process, including synchronous and (or) asynchronous interaction through the Internet.

The functioning of the Electronic Information and Educational Environment is ensured by appropriate means of information and communication technologies and the qualifications of the employees who use and support it. The functioning of the Electronic Information and Education Environment complies with the legislation of the Russian Federation.

Students with disabilities and learning difficulties are provided with printed and (or) electronic educational resources in forms adapted to their health limitations.

### 5.3. Staffing Arrangements for CPEDP

The staffing support for the CPEDP of training direction – 41.03.05 International

Relations is carried out by the university departments. The Graduate Chair is the Department of General History and International Relations.

Implementation of the Bachelor's degree program is provided by the managerial and scientific-pedagogical staff of the organization, as well as persons involved in the implementation of the program on the terms of a civil law contract.

Qualification of managers and scientific-pedagogical staff of the organization complies with the qualification characteristics established in the unified qualification handbook of managers, specialists and employees, section "Qualification Characteristics of Positions of Managers and Specialists of Higher Professional and Further Professional Education", approved by the order of the Ministry of Health and Social Development of the Russian Federation on January 11, 2011 N 1n.

More than 70 % of the number of university teaching staff involved in the implementation of the Bachelor's program, and persons involved by the university in the implementation of the Bachelor's program on other terms (based on the number of substituted positions, reduced to integer values), conduct research, educational, methodological and practical work that corresponds to the profile of the discipline (module).

More than 5 % of the number of university teaching staff involved in the implementation of the Bachelor's program and persons involved by the university in the implementation of the Bachelor's program on other terms (based on the number of substituted positions, reduced to integer values), are managers and (or) employees of other organizations, carrying out work activities in the professional field, corresponding professional activity, for which graduates are prepared (have work experience in this professional field not less than three years.

More than 60 % of the number of the University teaching staff and persons involved in the educational activities of the University on other terms (based on the number of replaced rates, reduced to integer values) have a degree (including an academic degree obtained in a foreign country and recognized in the Russian Federation) and (or) an academic title (including an academic title obtained in a foreign country and recognized in the Russian Federation).

## **5.4.** Assessment Criteria for the Quality of Educational Activities and for the Preparation of Students under CPEDP

The quality of educational activities and training of students in the Bachelor's degree program is determined within the system of internal assessment, as well as the system of external assessment, in which the university participates on a voluntary basis.

In order to improve the Bachelor's degree program, the university in conducting regular internal quality assessment of educational activities and training of students in the Bachelor's degree program involves employers and (or) their associations, other legal and (or) physical persons, including teaching staff of the Organization.

As part of the internal system of quality assessment of educational activities under the Bachelor's program, students are given the opportunity to assess the conditions, content, organization and quality of the educational process as a whole and individual disciplines (modules) and practices.

External assessment of the quality of educational activities under the Bachelor's degree program as part of the state accreditation procedure is carried out to confirm the compliance of educational activities under the Bachelor program with the requirements of the FSES of Higher Education, taking into account the relevant CPEDP.
